1. AGENCY shall provide CLIENT with investigative services which may result in: written reports, recorded statements, documents, photographic, video, audio, and related materials, as set forth by the terms and conditions below. CLIENT agrees that all reports will be submitted and received subject to the conditions of this Agreement.

2. Reports can be delivered via US Mail, faxed upon consent from CLIENT, hand delivered or delivered telephonically. CLIENT requests a written report: ___ YES ___ NO.

3. Unless otherwise agreed upon, it is agreed and understood that Client shall be solely responsible for compensation to said Agency at the hourly rate of \$___ per hour per investigator, \$.50 per mile, \$.50 per cell minute plus expenses incurred during or arising out of the course of the investigation. These rates apply the entire time we are working on your case, including travel time and mileage, to and from the nearest office.

4. The amount of \$___ is hereby deposited as a retainer. Any amounts or expenses incurred above the retainer fee listed above shall be due and payable immediately upon notice. Any unused portion of the retainer shall be returned to client within fourteen (14) days from the closing of the case.

5. In the event of default in payment of sums due by Client, and if this account is placed into collections, Client agrees to pay all costs of collection including but not limited to reasonable attorney fees.

6. Client agrees that any surveillance cancellation must occur 24 hours prior to surveillance. Otherwise, a four (4) hour charge will be incurred per scheduled agent, as well as any out-of-pocket incurred expenses.

7. In consideration of the foregoing terms and conditions, Client understands that Agency shall under its best efforts investigate the matter set forth above.

8. Client agrees to allow Agency to conduct the investigation at its sole discretion via any lawful means it deems appropriate.

9. If the investigation for which Client is contracting with Agency involves the locating of a person or persons, Client agrees to the following terms and conditions:

___ a. Client declares that Client does not intend for any unlawful act to be carried out against the above named individual(s) and/or his/her family or associates, by or through Client.

10. If any of this agreement shall be found to be invalid by a competent court, the remainder shall retain its full force and effect.

11. Client, Client's heirs, beneficiaries, devisees, legatees, administrators and assignees further agree to indemnify and hold harmless Agency and its agents and employees from any and all actions, causes of action, claims, damages and demands of whatever type wherever situated arising directly or indirectly from investigation which Client has requested.
